## ELECTORS INVITED TO CHECK NAMES, PARTICULARS IN DRAFT PUBLICATION OF ELECTORAL ROLLS

Panaji November 30, 2021

The draft Electoral Rolls in respect of all the 40 Assembly Constituencies in the State of Goa relating to the Special Summary Revision 2022 of Electoral Rolls with reference to January 1, 2022 as the qualifying date will be published as per the following programme approved by the Election Commission of India, New Delhi.

The schedule for various stages of special summary revision of photo electoral rolls of intensive nature- 2022 is as follows: Publication of Integrated draft Electoral Rolls on November 1, 2021, Period for filing of claims and objections on November 1, 2021 to November 30, 2021, Disposal of claims and objections on before December 20, 2021, Final publication of Electoral Rolls on January 5, 2022.

The draft Electoral Rolls will be available for scrutiny by the members of the public from November 1, 2021 till November 30, 2021 in the premises of the respective Polling Stations. The Electoral Rolls are also available for scrutiny in the Offices of the concerned Deputy Collectors and Electoral Registration Officers of Pernem, Bicholim, Bardez, Tiswadi, Ponda, Salcete, Marmogao, Quepem, Sattari, Dharbandora, Sanguem and Canacona and also in the Offices of all the Mamlatdars/Joint Mamlatdars/Assistant Electoral Registration Officers in the State of Goa.

All Indian citizens who are entitled to be included in the Electoral Rolls are requested to scrutinize the Draft Electoral Rolls and in case their names do not figure in the said Draft Electoral Rolls and those who may have attained the age of 18 years of age as on January 1, 2022 as qualifying date (born on or before 1/01/2004) are requested to get their names included in the Electoral Rolls in accordance with the procedure stated below.

All claims and objections for inclusion of names or objections to the particulars in entries in the Electoral Rolls should be made in Forms 6, 6A, 7, 8 and 8A, as the case may be and should either be presented to the concerned Electoral Registration Officers, Assistant Electoral Registration Officers, Booth level Officer or by online mode www.nvsp.in and voter helpline app.



The Booth Level Officer will be available at the polling booths on November 20, 21, 27 and 28, 2021 for collecting claims and objections.

All claims and objections received up to November 30, 2021 will be duly considered and disposed off by the concerned Electoral Registration Officers in accordance with the Registration of Electors Rules, 1960.

The electors as per the final roll previously published roll on January 15, 2021 with reference to 01/01/2021 as qualifying was 11,44,987. Whereas, after revision with continuous updation in draft publication to be published on November 01, 2021, the total number of electors will be 11,40,274. The percentage change over previous roll is -0.41%.

There is 100% photo coverage (General Electors) along with 100% EPIC coverage. Total overseas electors enrolled as on date is 78. The overall percentage of the EPICs will attain 99.99% for the State of Goa, during the current revision of Electoral Roll. The percentage of 18-19 years age electors is 1.67% of total population. The total form 6 admitted are 20219. The total voters deleted are 24932. Net change since previous roll is -4713 which is 0.41% change over previous roll.

During the continuous updation and as on date of draft publication of Electoral Roll, rationalization of polling stations has been carried out and 60 new polling stations were created, 17 in North and 43 in South. One polling station is deleted in South. The net changes in numbers of Polling Stations over the last Electoral Roll are 59. The total numbers of polling station have now increased from 1663 to 1722.

The Public in general and the Political Parties in particular are therefore requested to scrutinize the said Draft Electoral Rolls and to take steps to get names included or corrected, for which the time limit is upto November 30, 2021.
